



7. SAFETY TIPS

Maximum working load: 1 person - 150 kg



Check that the red handle to lock the outrigger is working properly

Before each use of the PIR platform, verify by visual inspection the following:

- Good state of the PIR platform and its accessories,
- Crimping (assemblies between stiles and rungs)
- Wear or lack of pads
- Possible presence of deformations of the elements
- The sound condition of welds
- Presence of the product identification label (fixed on one of the stile)
- For replacement of some elements, use only original FORTAL elements.

Tips for optimal use:

- Surfaces of use must be flat and not slippery
- Climb and descent of the platform always be done from the font
- Use suitable footwear providing safe support
- Never climb on the safety rails and tool tray.

Maintenance:

Clean regularly with a cloth the sliding parts to avoid damaging of the guiding system. .

8. WARRANTY

FORTAL guarantees its own manufactured products (excepting specific clauses accepted by the customer and FORTAL) for a period of 2 years from the delivery date (date given on the delivery note) against all manufacturing defects, with the exception of:

- Labour and travelling costs

Any modification, repair or replacement of parts during the warranty period does not extend the period of cover.

Should our manufactured products be modified outside our production site without our prior written agreement, FORTAL's liability cannot be incurrend.
